## Tēnā koe <sup>s9(2)(a)</sup>

Thank you for your request, received on 9 April 2024, and clarified on 16 April 2024, for the following information under the Official Information Act 1982 (the OIA):

"Updates/briefings/correspondence in relation to discussions the EA has had with the Commerce Commission and MBIE in relation to the s 36 complaints made from independent retailers (including Electric Kiwi's complaint), as well as any internal EA briefing reports on the matter, and extends to not only where there were specific references in those documents to s 36 of the Commerce Act but also where those documents included the following matters:

- (i) gentailer wholesale market power and conduct
- (ii) retail price/margin squeezes
- (iii) wholesale access (and pricing) to hedge products (OTC)
- (iv) internal transfer payments
- (v) the terms of reference/programme initiation document for the review of risk management contracts."

We note that you also confirmed that:

- a) The timeframe of the request is consistent with the start date of your OIA request of 25 January 2024 (i.e. from the date of the first independent retailer's complaint to the Commission) and up to 9 April 2024.
- b) The context of this request is still focused on seeking documents related to the independent retailers' section 36 complaints to the Commerce Commission last year, the Commission's assessment of those complaints, and Authority/MBIE/Commission communications, and Authority briefing reports, related to them. The request is not intended to capture documents or discussions related to the Authority's general work on, for example, wholesale market power and conduct. You have confirmed that you are not seeking our weekly trading conduct reports.

The Authority has identified 81 documents within the scope of your request. The Authority intends to release 74 documents in full or part, with redactions clearly marked where require a list of which

is included in Appendix A. We note that this list does not include documents that have been released to you under previous requests.

Some documents being released have sections redacted under:

- a) section 9(2)(a) of the OIA to protect the privacy of natural persons.
- b) section 9(2)(b)(ii) of the OIA to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.
- c) section 9(2)(f)(iv) of the OIA to maintain the constitutional conventions that protects the confidentiality of advice tendered by officials.
- d) section 9(2)(g)(i) of the OIA to maintain the effective conduct of public affairs through the free and frank expression of opinions.
- e) section 9(2)(h) of the OIA to maintain legal professional privilege.

The Authority is withholding 7 documents:

- a) one document in its entirety under section 9(2)(b)(ii)
- b) one document in its entirety under section 9(2)(b)(ii) and section 9(2)(h)
- c) three documents in their entirety under section 9(2)(g)(i)
- d) one document in its entirety under section 18(d)
- e) one document in its entirety under section 9(2)(f)(iv)

I am satisfied, in terms of section 9(1) of the Act, that the need to withhold the information referred to above is not outweighed by other considerations that render it desirable, in the public interest, to make the information available.
