



Tēnā koe s9(2)(a)

Thank you for your request, received on 25 January 2024, and clarified on 31 January 2024, for the following information under the Official Information Act 1982 (the OIA):

- "A list of external meetings, including names, roles, dates and times Anna Kominik has had as EA Chair since her appointment.
- A list of external meetings, including names, roles, dates and times that Sarah Gillies has had since August 2023.
- All updates/briefings/correspondence in relation to discussions the EA has had with the Commerce Commission and MBIE in relation to the s36 complaints from independent retailers (including Electric Kiwi's complaint), as well as any internal EA briefing reports on the matter."

On 29 February 2024, we wrote to you to inform you of our decision regarding the first two sections of your request under the OIA and informing you that we needed to extend the deadline for our response to the third part of your request by 20 working days, until 28 March 2024. This letter is to inform you of our decision regarding the third part of your request.

The third section of your request is centred on non-integrated retailers' section 36 complaints to the Commission. We have therefore focussed our response on documents relating to those complaints and the Commission's assessment of those complaints, and have not, for example, included documents recording Authority/MBIE/Commission communications relating only to the Authority's risk management review. We have also only included external communications and internal briefing reports, in line with the wording of your request. Please let us know if you consider that this interpretation does not reflect what you intended.

The Authority has identified 44 documents within the scope of your request, a list of which is included in Appendix A.

Some documents being released have sections redacted under:

- a. Section 9(2)(a) of the OIA to protect the privacy of natural persons.
- b. Section 9(2)(b)(ii) of the OIA to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.
- c. Section 9(2)(ba)(i) of the OIA to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same

- source, and it is in the public interest that such information should continue to be supplied.
- d. Section 9(2)(g)(i) of the OIA to maintain the effective conduct of public affairs through the free and frank expression of opinions.
- e. Section 18(d) of the OIA on the basis that the information is publicly available or will be available soon.

The Authority is withholding 3 documents in their entirety under section 9(2)(b)(ii) and section 9(2)(ba)(i) of the OIA, 2 documents in their entirety under section 9(2)(b)(ii) of the OIA, and 1 document in its entirety under section 18(d) of the OIA as it will be publicly available soon.

I am satisfied, in terms of section 9(1) of the Act, that the need to withhold the information referred to above is not outweighed by other considerations that render it desirable, in the public interest, to make the information available.
