The Authority is committed to engaging with our stakeholders in an open and collaborative way and welcomes the opportunity to meet with your organisation after the release of the review into competition in the wholesale market.

The review's observations, and a preliminary issues paper - which explores possible policy options - were both released this morning. The review has looked at elevated prices in the wholesale market from January 2019 to June 2021 and whether these prices were determined in a competitive environment. The papers are now available for feedback from interested parties from today until 8 December 2021, with all the information available on the Authority's website.

The consultation process provides a structured approach to most effectively capture all feedback.
