

Hello Jen

Thanks for the reply. The details of the power arrangement in the review are discussed at a general level and it does not refer to information that is not already in the public arena.

The Authority appreciates commercial sensitivities regarding the price agreed for supply of electricity and understand that, notwithstanding the widespread media and other sector commentator reporting, speculation and commentary, it has not been formally confirmed by either of the parties to the agreement.

This matter is addressed in the papers by avoiding repeating the actual price, or an approximate one like it, but instead by referring to a price range (\$30-\$40 MWh).

In this regard:

- **The Authority does not regard the general range in which the contract price sits to be confidential and/or commercially sensitive. Again, the report does not disclose the actual contractual price.**
- The Authority regards the publication of the general range in which the contract price sits as part of our consultation papers as being necessary to the Authority fulfilling its statutory function under section 16(1)(g) of the Electricity Industry Act 2010.

I would like to repeat my invitation for a meeting early following release of to gather your views and comments, and I am sure between us we can get something arrange at a time that suits.
